Mr. Gary Patrick was in attendance and informed the members that he had met with the Engineering and Planning Departments and received an explanation of the road costs and the sunset clause both affecting his property.

Mr. Patrick indicated that he had previously applied in 2001 for a building permit and had obtained quotes to upgrade the road but decided not to proceed. He noted that he did not receive any notification by registered mail that the road was being upgraded and assumed by the Town. He stated that if he had been notified he would have paid his share at the time.

Mr. Patrick confirmed that he will be building the new dwelling with a 2 car attached garage. He also reconfirmed that has no problem paying his share of the costs for upgrading the road as a condition of approval.

Ms. Margaret Howard-Gunn indicated that she had mailed a letter regarding the cost incurred for upgrading the road by regular mail and not registered mail.

Ms. Howard-Gunn asked the Committee if she will be reimbursed for all her cost of upgrading the road and if she would receive any interest on the money she had already paid. Stephen Pallett, Chairperson, noted that Ms. Howard-Gunn is only receiving the portion of the costs that pertain to Mr. Patrick's frontage and that no interest is paid on the money. The Secretary-Treasurer explained that if she fills out a request to be an interested party that she would receive a copy of tonight's decision.
