REPORT REGARDING FINANCIAL STATEMENTS FILED BY 2022 MUNICIPAL CANDIDATES & REGISTERED THIRD PARTIES AND CAMPAIGN CONTRIBUTIONS

Pursuant to Section 88.23(4) of the *Municipal Elections Act*, S.O. 1996, c. 32, ("Act") as amended, the Clerk shall make available to the public electronically or in another electronic format a report setting out all candidates in an election and indicating whether each candidate complied with Section 88.25 of the Act. Section 88.29(11) of the Act requires the Clerk to provide information regarding the filing of financial statements by registered third parties.

Following the 2022 Municipal Election, all candidates (unless they submitted a Notice of Extension of Campaign) were required to file Form 4, Financial Statement by March 31, 2023 at 2:00 p.m. or face certain penalties specified in the Act. However, under the Act, a 30 day extension was granted to candidates who did not submit Form 4 in a timely manner so long as the candidate filed by May 1, 2023, paid a \$500 late penalty and forfeited the nomination fee. Registered third parties faced the same deadlines but were required to file Form 8.

Additional sections of the Act require the Clerk to report the following:

- 1. Section 88.34(2)- Identification of each contributor to a candidate who appears to have contravened any of the contribution limits in section 88.9 of the Act.
- 2. Section 88.34(3)- Identification of each contributor who appears to have exceed contribution limits.
- 3. 88.36(2)- Preparation of a report identifying each contributor to a registered third party who appears to have contravened the contribution limits under the Act.
- 4. Section 88.36(3)- Preparation of a report in respect of each contributor who appears to have exceeded the limits in Section 88.13 of the Act.

All contraventions of contribution limits reported by the Clerk with respect to contributions to candidates or registered third parties are required to be forwarded to the Compliance Audit Committee. After a review of Form 4, the Clerk is of the opinion that there is no need, based on Form 4 filings, to report to the Compliance Audit Committee.
