Off-road Vehicle Pilot Project update

Council received the report regarding an update on the Off-road Vehicle Pilot Project. Council approved the recommendation to extend the project to continue during the period from Dec. 15, 2024 to April 15, 2025. The pilot includes all off-road vehicles as defined in the Highway Traffic Act, excluding dirt bikes.

Bi-annual traffic control and parking request work plan update

Council received the report regarding the bi-annual traffic control and parking request work plan. It provided an update on the status of traffic studies; new traffic management and parking control requests received since the last update; new initiatives for traffic calming; and recommended work plans to address these requests as well as provided required amendments to bylaws.

Tree Preservation and Compensation Policy update

Council received the report regarding the update to the Tree Preservation and Compensation Policy and endorsed the draft policy as the basis for further consultation with the public and stakeholders. Staff were directed to report back to Council on the results of further consultation and a recommended update to the Tree Preservation and Compensation Policy. Council also approved a recommendation to bring back an information report on a possible future municipal tree-cutting bylaw by Q4.

2024 Town of Georgina Waterfront Parks Master Plan

Council received the report regarding the Waterfront Parks Master Plan and endorsed it in principle. Staff were directed to report back through the annual budget deliberation process to activate priority capital improvements outlined in the master plan starting in 2025. Council also approved a recommendation for staff to bring the design for Willow Beach forward to the 2025 budget for Council's consideration, and, for staff to consider the feasibility of advancing the park portion of Young's Harbour earlier than what is suggested in the implementation plan.

Closed session

In regard to Closed Session Item 17.1.a under Sections 239(2) (f) of the Municipal Act being advice that is subject to solicitor-client privilege, including communications necessary for that purpose, regarding legal advice regarding improvements to Town-owned infrastructure;

Reporting out - that Council be directed to proceed accordingly.

In regard to Closed Session Item 17.1.b under Sections 239(2) (i) of the Municipal Act being a trade secret or scientific, technical, commercial, financial or labour relations information, supplied in confidence to the municipality or local board which, if disclosed, could reasonably be expected to prejudice significantly the competitive position or interfere significantly with the contractual or other negotiations of a person, group of persons, or organization, regarding naming rights prospect;

Reporting out - That Council receive the information and that staff be directed to proceed accordingly.

In regard to Closed Session Item 17.1.c under Sections 239(3.1) of the Municipal Act being an education and training session,

Reporting out - That Council receive the training provided.
