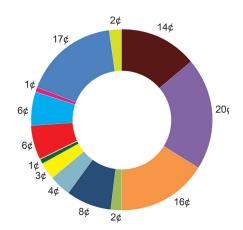
Your final 2024 tax bill is enclosed. This bill is payable in two instalments, the first on July 26, 2024 and the second on Sept. 26, 2024.

The Town of Georgina issues and collects your property tax billing, including those levied by the Town of Georgina, Region of York and Ministry of Education. The calculation of your property tax amount is determined by multiplying the current value assessment of your property by the applicable tax rate. We have provided within this brochure all 2024 tax rates for the Town of Georgina, Region of York and Ministry of Education.

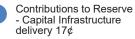

### **Budget summary**

Georgina Town Council approved its 2024 tax rates on May 29, 2024. When combined with the regional and education tax increases, the overall impact results in an increase of 4.19% or \$202.51 for the average home with a current value assessment of \$452,075. The Town of Georgina's 2024 Operating Budget, including contributions to reserves of \$12 million, is \$95 million. The 2024 Capital Budget is \$24 million, including \$3 million cash flows for the Civic Centre, for a total operating and capital budget of \$119 million. Funding sources for the tax levy supported expenditures are derived in part by revenues generated by user fees, permits and licences, federal and provincial grants, Canada Community Building Fund and development charges.

# Highlights of the 2024 budget include:

- \$4.5 million on road repairs and reconstruction under the pavement management strategy
- \$1.4 million for Ainslie Hill Park and trail development
- \$775,000 for Parks Repair and Remediation Program, this includes tennis and pickleball court resurfacing, and playground replacement at Udora Park and West Park
- \$250,000 for a Climate Change Action Plan
- \$225,000 for a Health Care Strategy and Action Plan
- \$120,000 for Lake Drive improvements phase 1

### Property tax payment options:

Payments can be made by telephone/internet banking or at any bank. Payment by Cheque or Debit can be made in person at the Civic Centre. There is a drop box at the front door of the Civic Centre for those wishing to drop off a cheque. For more information, visit georgina.ca/taxes.
