



Georgina Town Council June 19

Asset Management Plan for non-core assets

Council received the report regarding the [Asset Management Plan \(AMP\) for non-core assets](#) and adopted and endorsed the draft plan. The AMP provides a financial and technical roadmap for overseeing the Town's non-core infrastructure, namely facilities, parks, fleet, equipment, IT assets, active transportation assets, roadway appurtenances and urban forestry. It seeks to enhance the Town's ability to attain maximum benefits from its assets with proactive planning of expenditures while concurrently enhancing the quality of services provided to community members and staff.

Jericho Youth Services Partnership agreement

Council received the report regarding the Jericho Youth Services Partnership agreement, and authorized the Mayor and Town Clerk to enter into an agreement between Jericho Youth Services and the Town for the provision of after-school programs in the communities of Pefferlaw and Sutton for a five-year term expiring on June 30, 2029. Jericho Youth Services is a well-known, community-based, not-for-profit organization, delivering affordable, quality, community recreation programming opportunities (after-school programs) to support low- and moderate-income residents of Georgina. Continuation of the partnership agreement with Jericho will continue to provide a service that the community uses to its full capacity.

Introduction of Automated Speed Enforcement in the Town of Georgina

Council received the report regarding the introduction of Automated Speed Enforcement (ASE) in the Town and authorized the amendment of a bylaw to establish an administrative penalty system for violations of bylaws within the Town relating to the changes necessary to incorporate camera-based enforcement, consistency in appeals and general housekeeping in order to prepare for automated speed enforcement in Georgina. Staff will report back in Q3 to outline the final details for the program inclusive of location selection and criteria, financial outlook, and communications plan, along with any remaining bylaw amendments, prior to activating cameras in the Town. Council also approved a recommendation to request that York Region designate Belhaven as a community safety zone as there is a community hall and park and include it in their ASE program.

Proposed Memorandum of Understanding (MOU) between Southlake Regional Health Centre (Southlake), Northern York South Simcoe Ontario Health Team (NYSS OHT) and the Town of Georgina

Council received the report regarding the Memorandum of Understanding (MOU) between Southlake Regional Health Centre (Southlake), Northern York South Simcoe Ontario Health Team (NYSS OHT) and the Town, and authorized staff to enter into a non-binding MOU that

would formalize a collaborative relationship with Southlake and the NYSS OHT. Central to this collaboration will be the development of a new healthcare facility in Georgina to provide a suite of services to residents. Council approved modifying the Health Care Strategy and Action Plan, and repurposing the remaining budget to recruit a project lead resource to be managed by Southlake and reporting in through an agreed-upon governance structure that would be 100 per cent dedicated to implementing and advancing the MOU. The details related to the funding arrangements will occur through a separate funding agreement that will be tied to key deliverables, timelines and metrics with regular progress reporting to Council.
